Just as we think our paperwork is new, think again. There are new forms available for the two engraved

order forms and the non-engraved forms due the increase in the following:

The No. 1 Badge set in 10K gold is now \$140; the No. 4 10K gold Ancestor bar is \$90; on the nonengraved form the No. 1D '61 '65 bar is now \$30. On the Engraved Form 2, there is a new No. 45 Appointed General Officer Pin. Remember that all of the pins on this last sheet are \$55.

MDAH has released the Mississippi Confederate Pensions online. You can go to their website (http://mdah.state.ms.us/arrec/digital archives/pensions) and look up by last name the Confederate pensions of soldiers and widows in Mississippi. The copy of the pension is printable from the website. In 1888 Confederate pensions were granted to indigent soldiers and sailors only from Mississippi who had lost arm or leg. In 1890 the pensions were extended to indigent soldiers and sailors who was a resident of the state and had honorably served in the Confederate Army or Navy and also widows of soldiers and sailors who had not married. The pensions were granted 1888-1932.

I must remind you that administrative errors and lack of information on Memorandums of Facts for awards delays processing time which delays scheduling of Ceremonies of Bestowal.

A checklist that helps you in submitting correct information was enclosed in the President's Packets given out at the District Workshops; however, it appears that none are being used when preparing Memorandums of Facts. Please see your chapter

president to obtain a copy of this checklist and begin using it to process your applications.

Talking to the Veteran is always recommended if he/she is alive. Please provide a worksheet to each proposed recipient for Chapter's awards. There are things the veteran may know which are not on the DD214, such as his/her unit in Vietnam, Korea, or Iraq, for example. Veterans hate getting a certificate with the wrong unit on it. They all have a loyalty to their units, their flags and guidons, and their country.


MARY ANN RANDOLPH CUSTIS LEE 2583 HONORS LEFFLER BROTHERS AS WWII VETERANS.


Each officer gave a report for her area and presented ideas and suggestions to the chapters for smooth running and projects to consider.

If you are interested in purchasing a Mississippi Division (\$40) and Mississippi Division Page Pin (\$45), please contact me so I can send you an order form.

Ruth Allbritton, Vice President General, has sent to Division Vice Presidents and has published in the *UDC Magazine* each month updates concerning ordering insignia and the Winnie Davis and Stonewall Jackson Medals.

Please note that on the Non-Engraved Insignia Order Form, the price of the No. 33 Winnie Davis Medal w/Certificate is \$45; the No. 34 Stonewall Jackson Medal w/certificate is \$40. The order forms for the medals can be found on the UDC website and must be copied on legal, acid-free paper. This original and two copies must be originally signed and forwarded to me with the Non-Engraved Insignia Form with the check in the proper amount. The most important fact to remember is that the person being awarded these medals and certificates must meet the criteria. Please refer to the Handbook.

There is a new Engraved Insignia Order Form No. 2, which covers the newest approved pins. Each costs \$55 and includes engraving. These pins include the General Committee Chairman Pin, Division Officer Pin, Division Committee Chairman Pin, Chapter Officer Pin, General Officer Pin. and now, the Appointed General Officer Pin. These pins are a new option to having the No. 1A Plain Bar engraved with your offices. Pictures of these were printed in the Febuary UDC Magazine.

On the General level, there is a new 150th Commemoration Pin, created to sponsor Sesquicentennial Projects of the 150th Remembrance Committee. A \$150 donation to this committee, includes this pin, which can be worn on or off the UDC Official

Ribbon. It can also be worn by non-members. If worn on

the Ribbon, it is placed directly under the 150th Remembrance Pin.

Please remember that the Judah P. Benjamin Award now includes a Certificate and Pin, which may be worn on or off the Official Ribbon. This pin processes



through the Chairman of the Judah P. Benjamin Committee... not through the Vice President.

Please make sure that you include the appropriate proof when ordering the following pins: The No. 1 Badge Set or the No. 4 Ancestor Bar - please include a copy of the Membership Certificate or a copy of the 1st and 4th pages of the approved papers; the 10-, 25-, 35-, and 50-year Continuous Membership Pins - please include the red-stamped letter from the Business office; Member for Member Pin or Star - include Member for Member Sponsor form.

When ordering on either of the Engraved Insignia Order Forms, please make sure that you use one form and one check per order – do not combine. When using the Non-Engraved Insignia Order Form, you may combine items and write one check. Be aware that sometimes the items may be sent individually or held so that the whole order is sent all at the same time.


As always, NO STAPLES! No Cash. All orders must be shipped to the member ordering the insignia no third parties with the exceptions of the 10, 25, 35, and 50-year pins if the chapter is ordering one of these pins for presentation to the member. Please make sure that insignia orders go from the member through the Chapter Vice President to the Division Vice President.

Let me know if there are any questions all of this new information may have created. It's taken me some time to get it all straight. Go the the UDC website - www.hqudc.org - where you will find all these forms and much information. If you don't have internet access yourself, maybe someone else in the chapter can help you.
