Always on the lookout for Confederate sites, I was not disappointed on our trip to Austin, Texas in late May. Traveling through Huntsville, we stopped at the cemetery where Gen. Sam Houston is buried, along with many Confederate soldiers. I was also privileged to tour the Texas Capitol grounds to view the Confederate monument and one to John Bell Hood. On to the Texas

State Cemetery, we found the grave of Gen. Albert Sidney Johnston and many other Confederates.

Early June found me in Richmond, Virginia attending the Forty-Ninth Massing of the Flags at the UDC Memorial Building. Wow! I was so proud to present the Mississippi flag, being second in line because Mississippi was the second state to secede! On Sunday June 7, we boarded a bus to go to Arlington to attend the 101<sup>st</sup> Memorial Service at the Confederate Monument. I placed daisies on the graves of several Confederate soldiers.

I do hope that many of you took advantage of this summer travel period to get out and see the U.S.A. in your Chevrolet – or whatever means of transportation you used. In late June, Larry and I boarded a big, ol' bus with a group of thirty-something people and headed from Gulfport to Albuquerque, New Mexico. Oh, the places we saw that we had never seen before. Along the way, I looked for Confederate sites. The Old Town Plaza in Albuquerque did not disappoint with plaques about Confederate artillery Major Teel and the

mountain howitzers and two replica howitzers. There was also a plaque about the Battle of Albuquerque. Let's pray that these plaques remain there. In Santa Fe we found a Federal monument erected in 1868. I know; I know. But it did have carved on one side that it was "to the heroes of the Federal army who fell at the Battle of Valverde fought with the Rebels on February 21, 1862.

You know that I couldn't let the summer go by without a trip or two to Tennessee. While there on July 14, I stopped in Chapel Hill to have my picture taken at

the Nathan Bedford Forrest monument. It just so happens that Gen. Forrest was born just up the road from my home town of Lewisburg.

HEADQUARTERS for the 119<sup>th</sup> Annual Mississippi Division UDC Convention will be the Downtown Marriott in Jackson, Mississippi. The Convention Chairmen are Ruth Allbritton (District I) and Margaret Murdock (150<sup>th</sup> Anniversary Council). ROOM RESERVATIONS must be made directly with the Downtown Marriott, 200 East Amite Street, Jackson, Mississippi 39201, telephone or 1-800-442-0887. When making reservations, ask for the block reserved for "UDC" to obtain the convention rate. Convention room rate is \$109 for up to four persons per room and is available only for the nights of September 23 - 27, 2015. All reservations must be guaranteed with a major credit card. You will be charged for any room reservation not cancelled <u>48 hours</u> in advance. Rooms must be reserved by Thursday, August 20, 2015, to assure rate and availability. All room rates are subject to 11% tax plus a \$.75 charge. Each person is responsible for making her own reservation. It is recommended that you make your reservations as soon as possible. Joint Marriott Rewards to enjoy FREE Wi-Fi at the hotel. There is a \$12.00 per day parking charge for use of the Marriott parking garage.



### **President General Message**





# President General is Official Spokesman of the United Daughters of the Confederacy®

The General Officers have been working tirelessly on the distressing situations that have developed across the country. As we face these new challenges, please be aware that there will be situations we can intervene and/or offer advice, and situations that we will not be able to intervene based on the Bylaws of the General Organization and the rules governing Non Profit Organizations. The General Officers respectfully ask that all members be aware of the following:

UDC General Bylaws Article XXIII regarding Political Activity.

Article XXIII. Political Activities and Use of Roster

Section 1. Political Activities

It is prohibited for members, Chapters, or Divisions to participate in political activities in the name of the United Daughters of the Confederacy®. Membership in the UDC does not mean that you as an individual have lost your rights as a voting taxpayer of your County/Parish or State. You may participate in any political activity including lobbying (defined by IRS as attempting to influence legislation at any level of government) as an individual as is your legal right as a US Citizen. However, you may NOT do so as a representative of the United Daughters of the Confederacy as stated above in the General Bylaws Article XXIII.

2. UDC General Bylaws Article V regarding duties of the President General.

Article V. General Officers

Section 6. President General

The President General shall:

#### A. General.

1. Be the chief executive officer and the official spokesman of the United Daughters of the Confederacy. No member may speak for the United Daughters of the Confederacy except the President General as she is the Chief Executive Officer.

The General Executive Committee appreciates your cooperation in the two above stated matters.

## Katherine "Kay" Henry

It is with sadness that we announce the death on July 2, 2015, of our dear member and MS Division Vice President, Katherine "Kay" Henry.

Kay was a dedicated member of The United Daughters of the Confederacy for many years and served in various positions at the Chapter, District, and Division level. She was currently serving as President of the Putnam Darden 2242 Chapter in Starkville, District I Vice Chairman, a Division committee chairman, and as MS Division Vice President. Her dedication and influence in UDC will certainly be missed. Our thoughts and prayers are with her family and friends at this time. Her sister Carole Gospodnetich also serves as our Division Recorder of Military Service Awards.

Ruth Allbritton wrote this tribute and presented it with a rose and candle at Kay's Memorial Service:

"Katherine Camille Myers Henry (Kay) Joined the Putnam Darden 2241 Chapter United Daughters of the Confederacy on the service of her Great Grandfather James Franklin Benson, Co. H, 28<sup>th</sup> MS Cavalry, CSA, on Jan. 15, 2005. Her supplemental Confederate Ancestors are: GG Grandfather William Ellis Benson, G Grandfather Joseph A. Har-

gett, and GG Uncles Jason Hargett, General Lawrence Davis, Samuel M. Davis, and Cyrus Davis.

"Kay served her Chapter as president for nine years and held that office at the time of her passing. Kay served one term as District 1 Chairman and was serving as Assistant Chairman at the time of her passing. Kay served as MS Division Recording Secretary and was serving as MS Division Vice President at the time of her passing. She served as Chairman of several Division Committees.

"Those of us fortunate to know and work with Kay will never forget her dedication to whatever position she held. We will remember her laughter when telling a joke. We will miss her presence when we gather. We will miss Kay.

"To Kay we say:

"We are here to celebrate your life.

And every single life it touched, while you were here on this earth.

We wish to pay our last respects; that's why we are all here.

To thank you for your friendship and all the memories we hold dear.

It's been a privilege to have known you, we were family not just friends. And we will carry you in spirit until we meet once again."



### **Obituary for Kay Henry**

Katherine Camille (Myers) Henry was born in Starkville, Mississippi on January 8,1938 to Clyde R. Myers and Edith Benson Myers. She passed from this life on Thursday July 2, 2015. Visitation was held at Welch's Funeral Home, 201 W. Lampkin Street, Starkville, Mississippi on Friday July 10, 2015 from 5:00 pm to 7:00 pm. The funeral was held at same location Saturday, July 11, 2015 at 10:00 am. Burial was held in Odd Fellows Cemetery with Brother Eddie Painter officiating at funeral and grave side prayers.

Kay and her family (mom, brother and sister) moved to California following the death of her father in 1942. She lived there until 2001 when she and her second husband Jim moved to Starkville. She is survived by her husband James D. Henry, her Daughter Darcy Hollinger and husband Rick of Canyon Lake, California; her son James G. Bollinger and wife Donna of Starkville; her step-son James W. Henry II of Huntington Beach, California; sisters Carole Gospodnetich of Starkville and Nancy Bisconer of Elma, Washington; brothers Clyde R. Myers Jr. and wife Barbara Sue of Long Beach, Mississippi; and Robert Knowles and wife Penny of Bishop, California. There are seven grandchildren: Christopher Bollinger, Nicholas Bollinger, Chelsea Hollinger, Nathan Nunnery, Natale Nunnery, Sarah Henry, and James D. Henry II, along with various nieces and nephews.

Kay gave her life to many volunteer organizations that will miss her greatly. She served on the Board of Directors to the Oktibbeha County Heritage Museum, where she held

the seat as Secretary. She was on the Executive Board of the Oktibbeha County Historical and Genealogical Society where she served as Co-president and Treasurer. Her love of genealogy was a lifelong effort that lead to qualifications in the United Daughters of the Confederacy. All the years of research lead her to many Confederate soldiers which warranted her many merits in the UDC. She was a 45-year member of the Itawamba Historical and Genealogical Society where her mother also held a membership. She also assisted in articles in the Itawamba Settler paper and Magazine. Kay and her husband were instrumental in establishing and running the Longview Opry for over 14 years. She was a Board member and Treasurer for the Southern Cruisers Car Club of Mississippi and even had her own car: a 1951 Mercury 4door "custom." She loved to show and cruise her cars. She did volunteer work at the library in Starkville in the Genealogical Annex for special credits in the UDC.

She joined the United Daughters of the Confederacy in 2005. She was President of the Starkville Chapter, Putnam Darden 2242. She was the Mississippi Division Recording Secretary, District 1 Chairman, and at the time of her passing was serving as Mississippi Division Vice President.

Kay also had a special love for sewing, quilting, crocheting, knitting, and embroidery. She belonged to the Quilters Club in Starkville and showed many of her projects at street fairs, the Produce Barn, and County Annex Crafts Fair.

Words do not describe how I feel about all the support and best wishes Kay has received from all the "Daughters." You all have gone above and beyond in an effort to help Kay and her family. The UDC was a very, very important part of her life. I thank you for inviting both of us into your lives; it has been a blessing. A special thank you goes out to Ruth Allbritton (Kay's mentor) for performing an outstanding remembrance program at the funeral. I loved it, and so did many others. I don't know how long I can screen Kay's email site, so mine is jhenryjimhenry@aol.com. Please feel free to contact me any time, and maybe I'll see some of you at one of the conventions (??).


developing games, and presenting programs to other groups in addition to your own Chapter. A good source for new ideas will be the reports you hear during Division Convention.

Hello Ladies,

I hope all are having a great summer and staying cool.
Remember January is coming!

There have been changes made to all UDC membership applications, and the new forms will be on

the UDC General Website soon. The old forms can be used currently, BUT the new forms must be used as of September 1, 2015, which is the start of the new UDC year. The husband has been removed from the member information on page 2, and the marriage information has been removed from all generations. Marriage, divorce, or not married is immaterial to membership. The bloodline must still be proven, and marriage records can be used if you need that for proof of the bloodline. This affects all applications whether original, supplemental, or CofC to UDC transfers.

There are some issues with spacing on the date lines from Generation 3 down. They are being addressed and hope to be corrected soon. You may need to enter dates without spaces, which the Registrar General is aware of.

Also a reminder that all signatures must be original; you may fill in the application online and photocopy it, but signatures may NOT be copied.

Also, if you are using common proof, I only need one set of the proof, but each application must have its own checks. Remember the fees, and make those checks for the correct amount.

Please remember that the acid free copy of the applications MUST be front and back! I cannot send applications to the Registrar General or the Assistant Registrar General on 4 sheets. PLEASE save your Division Registrar a lot of work (and time). Thanks!




