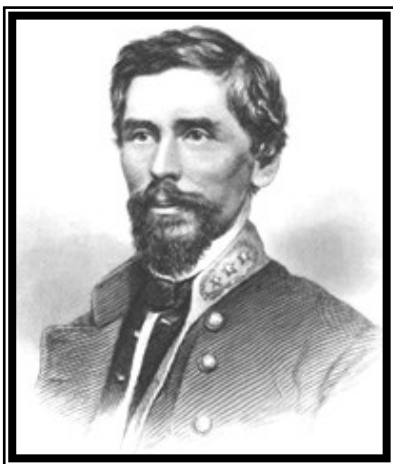

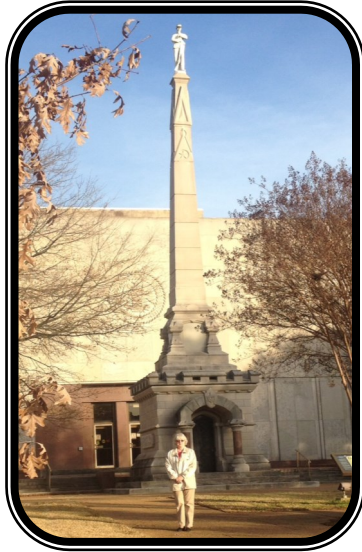

## 2nd Vice President



This is the time of the year when high school seniors typically begin to finalize plans for their first year in college. As acceptance letters begin to appear in students' mailboxes, the search for financial assistance has typically already begun. Full financial aid is rarely offered by colleges today. This means scholarships offered by other organizations such as the United Daughters of the Confederacy are highly

desired.

The Mississippi Division United Daughters of the Confederacy currently offers two undergraduate scholarships. Both the Margaret Howell Hayes Davis Scholarship and the Blanche Abels Burrell Scholarship are awarded from interest accrued on permanently designated funds. A third scholarship established in 2013 with funds donated by the Putnam Darden Chapter 2242, the Rebecca Hamner Scholarship, is currently being funded.

The application process begins with the applicant obtaining the appropriate forms from a sponsoring UDC Chapter and securing endorsement by the Chapter President and Second Vice-President. Qualifications for scholarship applicants include being a lineal descendant of an eligible Confederate. Collateral descendants are eligible provided they are a member of the CofC or the UDC. An applicant must have a 3.0 GPA to apply for a scholarship, and if awarded, the applicant must maintain a 3.0 GPA to reapply. The scholarship may be awarded for up to four years. New applications must be received by the Division Second Vice-President by **March 15**. Current

scholarship recipients may reapply by notifying the Division Second Vice-President in writing and sending an official transcript no later than June 1.

UDC Chapters wishing to sponsor an applicant should obtain the scholarship forms from the UDC General website under the members' only section or by contacting the Division Second Vice-President. The forms are the same for the Division and General scholarships. It is important that all of the forms are complete and that five sets (one original and four copies) are submitted to the Division Second Vice President. Incomplete applications cannot be considered for a Mississippi scholarship or be forwarded to the Second Vice-President General.

Not only does the application need to be complete, it needs to stand out. The rubric for evaluating scholarship applications communicates exactly what information should be emphasized by the applicant and in the reference letters. When properly utilized by the sponsoring UDC Chapter and the applicant, this valuable document can serve as a tool for formulating an outstanding application. The rubric can be found on the General UDC website.

Yes, assisting a student with the application process will require effort and time from the sponsoring UDC Chapter, and the deadline is rapidly approaching. However, it is also very satisfying to know that this organization is contributing to the education of the future leaders of our businesses, schools, churches, healthcare organizations, communities, and states. I look forward to receiving the applications from your Chapter.

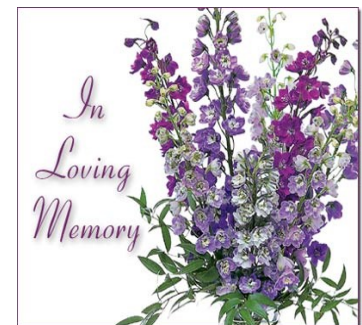
## From Our Chaplain

## Registrar

Hello ladies! Just a reminder that the supplemental fee at General will increase March 15 from 25 dollars to 30 dollars. If you send one before March 1 use the 25 rate, after that it must be 30. The Asst. Reg. General will accept any postmarked March 15, therefore I must have them before then and get them processed to mail to her then.

Ladies, please underline in **red** on each piece of proof exactly what you want us to see so we don't have to look for it. In the top right corner write what the piece of proof is, for instance Gen 3 F DC, is Generation 3 Female Death Certificate, that way we don't have to determine who it is for. Makes my job much easier as well as the job of the Registrar General.

If doing a supplemental, the date the supplemental is Chapter approved is not the date the original membership application was approved. It is the date of the supplemental approval. For example, Mary Jane Doe Smith's original application was approved on 6 June 2001. She filed a supplemental

on 18 Mar 2003, and that is the Chapter approval date.

On supplemental applications the Asst. Registrar does NOT want the pages stapled together, and has specified that. Please do not leave lines blank — show something. If the person is living, write "living" and on the where line show where they live, such as Corinth, Alcorn County, Mississippi. On marriage dates look at the certificates and list the date the minister or justice of the peace performed the marriage — not the date the license was issued.

I am very excited about all the hard work being done by Chapters and look forward to lots of work in the future. I am here to help in any way I can. Don't hesitate to call if I can help in any way.

### GUIDELINES FOR MS DIVISION ESSAY CONTESTS

Essays must be received before March 15, 2015.

These are the subjects for the Eleanor Shands Essay Contest for 2015:

- \* Junior High (grades 6-8): **"Civil War - A Soldiers Life"**
- \* Senior High (grades 9-12): **"Collapse of the Confederacy from 1864 to 1865"**

Each essay must be at least 400 words and up to 600 words. It must be typed and doubled spaced. Footnotes documenting sources are required, as well as a complete bibliography. Direct quotes must be in quotation marks. The term **"Civil War"** should not be used **EXCEPT** in direct quotes. Use the term **"War between the States."** Make sure that your name, age, school, and grade is at the top of the paper. 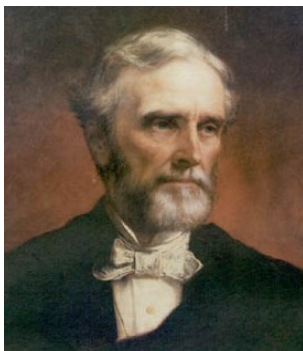
## Division Growth

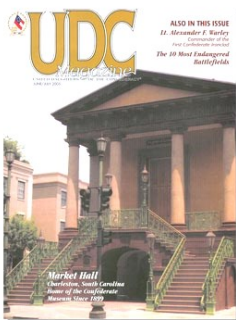

## Lee-Jackson Birthday Banquet Robert E. Lee Chapter 2561 & Winnie Davis Chapter 24

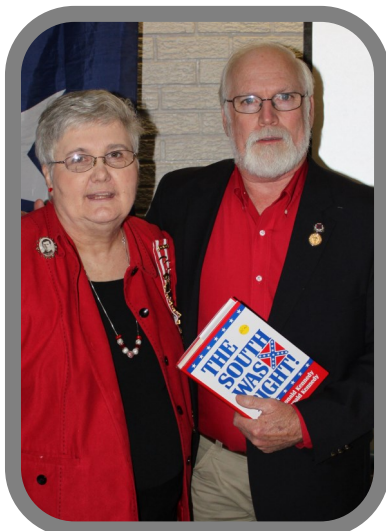

*media and news outlets of the day at a time when photography was in its relative infancy.”*

*“The first-hand drawings selected for this exhibition, most of which have never been published, document in lively and specific ways key developments in the history of America as it struggled to establish its national identity. The exhibition contains over 85 original drawings, many made on battlefields and barracks amidst the maelstrom of the Civil War. The Museum’s presentation of these important works commemorates the 150th anniversary of the end of the Civil War, emancipation, and the steps toward reunification of the nation.
