424 markers of Mississippians buried in the McGavock Cemetery. They died fighting the Battle of Franklin, Tennessee. A committee was named with Ruth Allbritton of General M.P. 1. If you are ordering a continuous membership pin, please remember that you, the member, **MUST** contact the business office for verification of continuous payment. That is the only form I can accept.
2. If you are ordering an ancestor bar, you can take away from your proof if you need to do so for engraving purposes but you **CANNOT** add to your proof. For example, if your certificate says "Jonathan Benjamin Johnston," you may use "Jonathan B. Johnston." If your proof says "Jonathan B. Johnston," you may **NOT** use "Jonathan Benjamin Johnston."
3. Remember that the space between names does not count, but a period (.) or dash (-) does count.

**I**t is that time of year for our high school seniors to start filling out their

scholarship applications. I have mailed each Chapter's Second Vice President or President a hard copy of the Mississippi Division Scholarship application form, checklist, rules, and information for potential applicants. I hope each of you have reached out to your high school seniors and given them a copy of the scholarship rules and forms. **I pray there are applications being completed as the deadline for receipt of the required materials is March 15!**

The Mississippi Division United Daughters of the Confederacy currently offers two undergraduate scholarships: the Margaret Howell Hayes Davis Scholarship and the Blanche Abels Burrell Scholarship. A third scholarship established in 2013 with funds donated by the

Putnam Darden Chapter 2242, the Rebecca Hamner Scholarship, is currently being funded.

The application process begins with the applicant obtaining the appropriate forms from a sponsoring UDC Chapter and securing endorsement by the Chapter President and Second Vice President. Qualifications for scholarship applicants include being a lineal descendant of an eligible Confederate. Collateral descendants are eligible provided they are a member of the CofC or the UDC.

Yes, assisting a student with the application process will require effort and time from the sponsoring UDC Chapter. However, it is also very satisfying to know that this organization is contributing to the education of the future leaders of our businesses, schools, churches, healthcare organizations, communities, and states. If you have any questions, please contact me. I look forward to receiving the applications from your Chapter!




**Daisy Estelle Burnham Reed**

Miss Daisy taught school in the 1940s and 50s at Good Hope, Sulphur Springs, Chewalla, and Reed's schoolhouses. She enjoyed gardening, reading, cooking, sewing, and spending time with loved ones. She was 95. Miss Daisy's grandson Ryan Reed is a former recipient of the General M.P. Lowrey Scholarship and a graduate of Blue Mountain College. Her service was conducted by Ryan.



## Our Confederate History

During Lincoln's illegal war on the South in Florida, there lived a Cuban gentleman named Mauritia Sanchez. His family included three daughters who were well known for their beauty, Panchita, Lola, and Eugenia. Suspicion fell on Mr. Sanchez as a spy for the Confederates, and the old man was torn from his home and made a prisoner in the old Spanish Fort in San Marcos (now Fort Marion) at St. Augustine. The girls occupied the home with their mother and were entirely unprotected.

It was usual for Yankee officers to visit at their home, and the girls were wisely cordial to them. A measure of protection was given to the women from the thieving Union soldiers in St. Augustine because of the Yankee officers that spent so much time at the home.

One night three Yankee officers came to the Sanchez home to spend the evening with the girls, who often cooked for them and made them Cuban coffee. After a while, the girls left the officers and went to fix supper. The soldiers, thinking they could speak freely, discussed a plan to surprise the Confederates on Sunday morning by sending gunboats up the river and also planned a foraging party from St. Augustine. When Lola heard this, she stopped working and paid attention. After learning everything she could, she told Panchita to entertain them until she returned. Stealing softly from the house, she ran to the barn, threw a saddle on her horse, and rode a mile away to the ferry. From there, the ferryman took her horse and gave her a boat. She rowed across the St. Johns, met one Confederate picket who knew her, and he gave her his horse. She rode like the wind to Camp Davis, a mile and a half away. Reaching the camp, she asked for Captain Dickinson and told him the Yankees were coming and that the troop from St. Augustine would go out foraging to the South. Leaving camp, Lola rode for her life. She knew she must not be missed from home. Giving the picket his horse back, she crossed the ferry again, hitched her waiting

horse and high-tailed it for home. She dismounted away from the house, turned her horse loose, and got home in time for supper. It was very dangerous for Lola to do what she did, because the Yankees knew information had been coming from that house.



The next Sunday morning, the Yankee gunboats went up the St. Johns to surprise the Confederates. However, the Yankees were the ones surprised! The Confederates were ready for them, disabled a gunboat, and captured a transport along with many prisoners.

Time and again these Latina daughters of the Confederacy aided and abetted the Southern cause. Sometime after this incident, a pontoon was captured and renamed "The Three Sisters" in honor of these brave young women.

Eugenia and her daughter were members of the Anna Drummet Chapter UDC in St. Augustine. The granddaughters of Lola and Panchita were members of the St. Augustine Chapter of the Children of the Confederacy, which was named in honor of Gen. W. W. Loring. At the FL Division Convention in 1909, the granddaughters served as pages.

There is a plaque in the UDC building that bears the names of the Sanchez sisters as heroines of the Confederacy.

## Mississippi Division McGavock Confederate Cemetery Project

Congratulations and THANK YOU to the members of MS Division UDC and our friends who have stepped up to remember the MS Confederates killed at the Battle of Franklin and buried in the McGavock Confederate Cemetery. All 424 Mississippians buried in the cemetery have been adopted and have not, and will not, be forgotten. Your generous contributions have furnished new markers for these men who made the ultimate sacrifice. MS Daughters and friends have walked in the footsteps of our predecessors by ensuring these men's graves have been re-marked.

The McGavock Confederate Cemetery Corp. has ordered the markers and will soon begin to place them. The MS Division collected a total of \$9,667.00 with \$297.00 sent directly to the bank by two Chapters. A total of the two is \$9,964.00, the

amount required for re-marking of the 424 MS gravesites.

The MS Division McGavock Cemetery Project Committee commends you for the completion of this project in only eight months. We encourage you to visit the cemetery and pay your respects to these Mississippians who rest forever away from home.

A special thank you to Susan Dunn for the weekly updated database and to Sharon Tallman, Editor, for posting each update on our MS Division website.

Dear Ms. Allbritton and the Ladies of the Mississippi Division UDC:

The trustees of the McGavock Confederate Cemetery Corporation would like to thank you for your recent donation of \$9,667.00 toward our restoration project for the purchase of 6 x 6-inch granite "cornerstones". This donation along with previous donations from several Mississippi UDC Chapters completely pays for the cornerstones for the 424 Mississippi Confederates who died in the Battle of Franklin and are buried in the McGavock Confederate Cemetery. Our project to purchase approximately 1,250 cornerstones to place in front of each of the present gravestones will aid visitors to the cemetery in their quest to locate their ancestor, as many names on the current limestone markers are unreadable. The new granite cornerstones contain the same information as the original limestone markers, many of which have been in place for more than 125 years. All of the cornerstones have now been ordered, several of the sections have been completed and we hope to have them all in place by spring, 2018. Your efforts to raise the money to pay for the entire Mississippi section is to be commended.





Restaurant for food and fellowship. The guest speaker was Anne McKee, who presented a program on “Sherman’s Forgotten Campaign.”



Our speaker for the evening was David Proctor formerly of Ethel and now residing in Columbia, Mississippi. He is a re-enactor with the 15<sup>th</sup> Mississippi and an avid student and collector of all things pertaining to the War Between the States. Having recently read the book The Great Sweet Potato Raid, David spoke at our banquet of the events surrounding the Great Sweet Potato Raid of 1864.



During the winter of 1864, the Federal Cavalry cut a swath from Baton Rouge to Pascagoula. They were bent on destroying everything in their path. As the Union troops made their way through Marion County, everything was stripped bare. The sweet potatoes that had been banked for the winter were taken.

Following the war, the Southern Claims Commission was formed to reimburse the Southerners for lost livestock and crops. Rarely were any of the Southern farmers reimbursed for their losses.

Following Proctor’s speech, the banquet attendees honored their ancestors by lighting candles. With all overhead lights turned off, the room glowed from approximately 100 candles. As each person called out their ancestor’s name, a flame was extinguished. This ceremony was very moving as we remembered our soldiers and the hardships they faced in defending the Southland long ago.

In researching his ancestor, Mr. Arnold discovered that Turner Hall was a free man of color before the War Between the States. He was twenty-one years old in 1860 and decided to serve in the Confederate Army. Arnold said Hall was at Appomattox when Lee surrendered to Grant. After the War, Hall came back to Okolona. Later he ended up in Hugo, Oklahoma. Turner Hall died at the age of 102 years old, and he was returned to Mississippi for burial.


